Workshop Venue

How to reach Diamant Conference Centre by public transport:

Bus and pre-metro lines have their stop at “Diamant – station” under the Reyers viaduct. The Diamant Conference Centre is located a few steps further on the corner behind the bridge – next to the “RTBF” – radio and television tower.

- From the airport (+/- 30 min.):
 - Bus line 21 direction “Ducale” or 12 direction “Luxembourg”
- From the European Institutions – Schuman (+/- 15 min.):
 - Bus line 79 direction “Kraainem”
- From Central Station (+/- 20 min.):
 - Metro line 1 direction “Stockel”, stop “Montgomery”
 - Pre-metro line 25 direction “Rogier” or 7 direction “Heyzel” for 2 stops
- From Midi Station (+/- 30 min.):
 - Metro line 2 direction “Simonis Elisabeth”, stop “Arts-Loi”
 - Metro line 1 direction “Stockel”, stop “Montgomery”
 - Pre-metro line 25 direction “Rogier” or 7 direction “Heyzel” for 2 stops.

How to reach Diamant Conference Centre by car:

1. A) From E40 “Ostende” or E19 “Antwerpen”:
 - Close to “Brussels”, turn right: R0 towards “Zaventem” – E411 “Namen/Namur”.
 - Take the exit: E40 / A3 towards “Luik – Leuven – Brussel”.
1. B) From E19 “Mons – Bergen” or E411 “Namen – Namur”:
 - Close to “Brussels”, turn right: R0 towards “RING-EST” (coming from Mons) or “Zaventem” (coming from Namur).
 - Take the exit: E40 / A3 towards “Sint-Stevens-Woluwe / Brussel – Luik – Leuven”.
2. Take direction “Brussel”:
 - Take the exit 18 towards “Meiser – Reyers” right before the tunnels and keep extremely right. You are at the backside of the Diamant Building. Follow “Kolonel Bourg” street until the cross point with the “Boulevard A. Reyers”. Turn right and a few meters further you can enter Diamant’s underground parking at your right side after the building.

Introduction to the BIC project

The purpose of the BIC coordination action project is to foster cooperation across the international programme agencies and researchers within the focus areas of ICT Trust and Security, in order to:

- (a) understand the activities and planning of the target countries; and
- (b) carry out a mapping of the European Commission's planning to them, such that a common technical and policy alignment is viable.




Figure 1. Overall structure of BIC project and external bodies

The building of international cooperation is a collaborative effort that only works if it reflects the views and priorities of the target countries as well as buy-in from technical experts of the EU along with the target countries. Hence, this component of community building is a key role of the Working Groups (WGs) of BIC as shown highlighted in figure 1. The areas and scope of the three working groups were agreed during the [First BIC Annual forum¹](#) held in November 2011 and this set of workshops over two days are the launching workshops of the three BIC WGs:

1. **WG1. Human oriented /citizen trust, privacy and security**, which will focus on topics related to a multi-disciplinary approach for international cooperation amongst all stakeholders;
2. **WG2. Network Information security / Cybersecurity**, which will focus on topics related to the need for international cooperation for enabling the protection of networks and systems;
3. **WG3. Programme /funding focus/ identify community**, which will focus on the requirements, processes, mechanisms and barriers to enable collaboration opportunities.

Terms of Reference Day 1 (21st June 2012)

Title: Coordination of the cross domain activities in International Cooperation

Background: The European Commission is advocating and supporting strong cooperation internationally, with the following objectives:

- To jointly develop ICT solutions to international societal and economic challenges relating to the security and trustworthiness of the global ICT systems, services and infrastructures;
- To jointly respond to major global technological and operational challenges by developing interoperable solutions and standards;
- To improve scientific and technological cooperation for mutual benefit.

At the [**1st BIC Annual Forum**](#)² in November 2011, a key recommendation was made for enhanced coordination and information-sharing across the variety of bi-lateral International Cooperation (INCO) activities sponsored by the European Commission. As BIC spans multiple countries with a unique multi-lateral profile, BIC aims to further this recommendation by hosting a workshop that brings together the multiple projects and stakeholders that are already engaged in International cooperation with the intent to:

- Explore the insights and common experiences across projects;
- Identifying, discussing and assessing (a) key challenges, issues and priorities; and (b) mechanisms for international cooperation that are already available;
- Explore possible synergistic approaches for mutual collaboration, cooperation and organising future joint INCO research activities and its supporting programmes.

Objectives: The Workshop aims to achieve the following concrete outcomes:

- From the experiences and insights of the participants, determine the ways to move forward on international cooperation, and future calls for collaborative research;
- Forming the current bi-lateral (and potentially overlapping) country to country cooperation into a comprehensive and coordinated global cooperation;
- Compiling a *who's who* directory of agency and research contacts across the countries;
- Identification of “success metrics” for international cooperation and collaboration:
 - rationale – motives and goals – engagement in international cooperation;
 - success criteria with regard to results;
 - analysis and assessment of INCO impact.

Format: After the opening plenary session, there will follow a number of round table style interactive sessions composed of a series of presentations and discussions of topics each with a nominated moderator. In order to be more concrete in terms of results, each session will be as self-contained as possible, generating input to the workshop results highlighted by assigned rapporteurs in conjunction with the moderator and participants.

Terms of Reference Day 2 (22nd June 2012)

Title. BIC technical workshop on International Cooperation in Trustworthy ICT

Background: While the focus on Day 1 of the workshop will be on the requirements, mechanisms and processes involved in building a long term strategy towards international cooperation in the RTD programme in broader areas than just Trustworthy ICT, the focus on Day 2 will be on the two technical working groups of BIC, specifically dealing with Trustworthy ICT, namely,

1. **WG1. Human oriented /citizen trust, privacy and security**, which will focus on topics related to a multi-disciplinary approach for international cooperation amongst all stakeholders;
2. **WG2. Network Information security / Cybersecurity**, which will focus on topics related to the need for international cooperation for enabling the protection of networks and systems;

Objectives: The Workshop aims to facilitate the WGs to provide the following outcomes:

- Refine thematic focus within the domains covered by the WGs by leveraging domain knowledge, familiarity with context and environment and research experience. Shortlist a set of actionable themes to be taken up in the EU-International joint research context.
- Identify and validate long term common shared research perspectives for international cooperation of mutual interests, aligned with the ICT trust and security research domains within the EU research vision and priorities (FP7 and H2020);
- Represent stakeholder views to be expressed toward the decision makers (the European Commission and the respective Governments for which they carry out research) in the formulation of enabling and relevant policies;
- Provide expert advice to BIC in thematic areas of competence and direct the project consortium to material, publications, activities, projects that might be of interest to BIC, its objectives and actions;
- Assist the BIC project to leverage its actions into achievements within the larger community of stakeholders and institutions. This would include being an advocate for the project and taking part in the organisation of local workshops to broaden the community of participants within their respective countries.

Format: After the opening plenary session, the WG sessions consist of a series of discussions of identified topics for international cooperation in trustworthy ICT each led by nominated person(s) as a topic 'animator(s)'. The animator(s) will open the topic with a short presentation and open the floor to all participants to actively involve themselves within the topics of their expertise. In the middle of the workshop, the breakout groups will return to plenary to reflect and take stock of where each WG is at that time. Ample time will be allotted to new topics of interest that might not have been raised already. The workshop will seek to provide tangible results along the lines of internal actions and work-items for the working groups and external recommendations and suggested actions towards the scoping of issues, priorities and topics for future INCO projects.
